3. Personnel Evaluation Plan Addendum - Bulletin 130

Section 105. Framework for LEA Personnel Evaluation Programs Section 3: Observation/ Data Collection Process

The evaluator or evaluators of each teacher and administrator shall conduct a minimum of one formal, announced observation and at least one other unannounced formal, observation of instructional practice per academic year. Each formal teacher observation must last at least one complete lesson. For each formal observation, evaluators shall conduct a pre-observation conference with their evaluatee during which the teacher or administrator shall provide the evaluator or evaluators with relevant information. For both formal and informal observation, including areas for commendation as well as areas for improvement. Additional evidence, such as data from periodic visits to the school and /or classroom as well as written materials or artifacts, may be used to inform evaluation. One of the observations may be waived for teachers who have earned a rating of highly effective according to the value-added model in the previous year.
